

In continuation of the Proc's in the reference 6th cited and as per the circumstances stated by the Correspondent, **Geethika School, Brahmanapalli Village, Piduguralla Mandal** in the reference 2nd read above, the District Educational Officer, Guntur is hereby accorded grant of provisional Recognition to classes Nursery to V (EM) from 2018-2019 to 2027-2028 in respect of **Geethika School, Brahmanapalli Village, Piduguralla Mandal, Guntur District** subject to the fulfillment of the following conditions.

- 1) That the society shall abide by the rules and regulations made in the Government orders in 1st to 2nd read above cited above and also issued from time to time.
- 2) That the Educational Institution shall needs of the locality more particularly.
- 3) That the Institution shall adopt curriculum and syllabus prescribed from time to time by the Govt., of AP.
- 4) That the school timings, vacations and mid terms holidays shall be prescribed by the government from time to time.
- 5) That the qualified staff with in the age limits prescribed by the Government for Government employees shall be appointed as per the staff pattern.
- 6) That the results of the institution shall be satisfactory of every year.
- 7) That the records / accounts, annual administrative report along with the audited accounts should be submitted to the District Educational Officer, every year.
- 8) That the list of Governing Body shall be furnished to the D.E.O., every year.
- 9) That the pay structure / fee structure fixed by the Governing body shall be submitted to the District Educational officer every year.
- (10) That all the conditions prescribed in the G.Os and other orders which are not specified in this orders shall be complied with.
- (11) That the school shall not be closed with out giving notice both to the parents / Dist. Ednl, Officer, and the competent authority at least 6 months before.
- (12) That the school shall be closed (or) permitted to be closed only from the date on which summer vacation is declared.
- (13) That the society shall submit proposals for renewal of Provisional Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of recognition.
- (14) The school management is requested to submit an affidavit every year with regard to non violation of rules / regulations prescribed by the Government from time to time.
- (15) Economic strength should be maintained in all classes.


